### Course Description

The senior design (EENG 4990) course is a comprehensive electrical engineering design course sequence providing major design experience. Building upon the project proposal and conceptual design developed in the Senior Design I (EENG 4910) course, this course encompasses detailed design, implementation, and documentation of the project. Project deliverables include a comprehensive project final report, oral presentation, poster presentation and demonstration of the project.

### Course Structure

The capstone senior design course is a comprehensive electrical engineering design course designed to satisfy ABET\_EAC engineering design criteria. Each and every senior project will be part of documentation for review by ABET evaluators. Students may choose a design topic in VLSI, communications, Signal Processing or any other electrical engineering area. Substantial design work is required for passing this course. During the senior design-I(EENG 4910), students are expected to develop a comprehensive project proposal and conduct research that results in a conceptual design. In the senior design-II (EENG 4990), detailed design, implementation, and documentation are conducted.

The project deliverables include a comprehensive project proposal about the conceptual design of their project for EENG 4910. A final report, oral presentation, poster presentation and demonstration of the project constitute the deliverables for EENG 4990. All work submitted must be approved by the faculty advisor. All assignments should be submitted electronically, and the feedback is provided electronically.

### Course Prerequisites

EENG 3810 and EENG 3811, EENG 3910, EENG 3920, all of which must be completed with a grade of C or better.

### Course Objectives

By the end of this course, students will be able to:

1. *Design a system or process to meet specifications with engineering constraints.*
2. *Function as a member of an engineering team.*
3. *Utilize technical resources both from prior coursework, as well as from other relevant sources.*
4. *Demonstrate excellent written and oral communication skills related to design project results.*
5. *Demonstrate an understanding of ethical and professional issues as well as engineering standards related to their projects.*
6. *Demonstrate an understanding of contemporary issues as related to their projects.*

### Materials

There is no prescribed textbook.. We review the material from Project II textbook “R. M. Ford and C. S. Coulston, Design for Electrical and Computer Engineers - Theory, Concepts and Practice, New York: McGraw-Hill, 2008” early in the course. This material provides the basic approach for writing an engineering project proposal. This is complemented by sample proposals from previous semesters. Other materials from websites of UNT EE department, ABET and National Academy of Engineers will be made available. Most of the classroom presentations will be made available on CANVAS.

### Teaching Philosophy

The course is designed to meet the ABET EAC criteria with respect to Engineering Design. Students will be provided a checklist of expectations “Engineering by Design TM, Advancing Technological Literacy, International Technology Education Association EP - 2009- 03-51- NASA-MSFC” in Engineering Design. EENG 4910 course will concentrate on items 1-7 of the checklist and EENG 4990 will be meeting all items of the checklist. Additionally, students will be provided a rubric that will be used to grade their Project proposals as well as Project Final report, Final presentation and the Project design.

**Laboratory Resources:** The Senior Design Lab M 201 is designated for exclusive use by Senior Design students. After the first week of classes, students will be able to access the laboratory with their student ID cards.

**IMPORTANT NOTE:** Due to a national shortage of electronic components, there is a long delay in getting the components needed for projects. It is prudent to complete your conceptual design, identify the electronics parts needed and initiate purchase orders as early as possible. After you identify the parts needed, and a source where they are available, please send a request to your faculty advisor for approval (and cc me).

## Important Notice for F-1 Students taking Distance Education Courses

### **Federal Regulation**

To read detailed Immigration and Customs Enforcement regulations for F-1 students taking online courses, please go to the [Electronic Code of Federal Regulations website](http://www.ecfr.gov/) (<http://www.ecfr.gov/>). The specific portion concerning distance education courses is located at Title 8 CFR 214.2 Paragraph (f)(6)(i)(G).

The paragraph reads:

(G) For F-1 students enrolled in classes for credit or classroom hours, no more than the equivalent of one class or three credits per session, term, semester, trimester, or quarter may be counted toward the full course of study requirement if the class is taken on-line or through distance education and does not require the student's physical attendance for classes, examination or other purposes integral to completion of the class. An on-line or distance education course is a course that is offered principally through the use of television, audio, or computer transmission including open broadcast, closed circuit, cable, microwave, or satellite, audio conferencing, or computer conferencing. If the F-1 student's course of study is in a language study program, no on-line or distance education classes may be considered to count toward a student's full course of study requirement.

## University of North Texas Compliance

To comply with immigration regulations, an F-1 visa holder within the United States may need to engage in an on-campus experiential component for this course. This component (which must be approved in advance by the instructor) can include activities such as taking an on-campus exam, participating in an on-campus lecture or lab activity, or other on-campus experience integral to the completion of this course.

If such an on-campus activity is required, it is the student's responsibility to do the following:

(1) Submit a written request to the instructor for an on-campus experiential component within one week of the start of the course.

(2) Ensure that the activity on campus takes place and the instructor documents it in writing with a notice sent to the International Student and Scholar Services Office. ISSS has a form available that you may use for this purpose.

Because the decision may have serious immigration consequences, if an F-1 student is unsure about his or her need to participate in an on-campus experiential component for this course, s/he should contact the UNT International Student and Scholar Services Office (telephone 940-565-2195 or email [internationaladvising@unt.edu](mailto:internationaladvising@unt.edu)) to get clarification before the one-week deadline.

### Use of Student Work
